ITEM #2 SCOPE OF SERVICES

DELETE: the following from SCOPE OF SERVICES in the RFQ:

"The Contractor shall provide HANO up to forty (40) billable hours ...beginning upon execution of a contract and ending on September 30,

2018."

INSERT: the following into the SCOPE OF SERVICES in the RFQ:

"The Contractor shall provide HANO up to forty (40) billable hours ...beginning upon execution of a contract through September 30, 2019."

ITEM #3 CONTRACT PERIOD

DELETE: the following from the SUPPLEMENTAL CONDITIONS, Contract Period:

"This Contract shall be for the period beginning upon execution of a

contract through September 30, 2018."

INSERT: the following into the SUPPLEMENTAL CONDITIONS, Contract Period:

"This Contract shall be for a period of one (1) year beginning upon

execution of a contract through September 30, 2019."

ITEM #4 WRITTEN QUESTIONS RECEIVED

Q1: In the Scope of Services section, the RFQ states "The Contractor

shall provide HANO up to forty (40) billable hours, beginning upon

execution of a contract and ending September 30, 2018".

Is it correct, that the contract is only up to 40 hours and only

occurring in September of 2018?

A1: Yes, the contract shall be up to forty (40) billable hours. Also, refer to Item

#3 above.

Quotes must be received by the Housing Authority of New Orleans (HANO) in the Office of Procurement and Contracts by 2:00 p.m., local time on Thursday, September 6, 2018. All terms and conditions shall remain as stated in the original Request for Quotes. All addenda must be acknowledged.
