Considering the petition, testimony and arguments of counsel, the Court finding the law & the evidence to be in favor of plaintiff for reasons this day orally assigned:

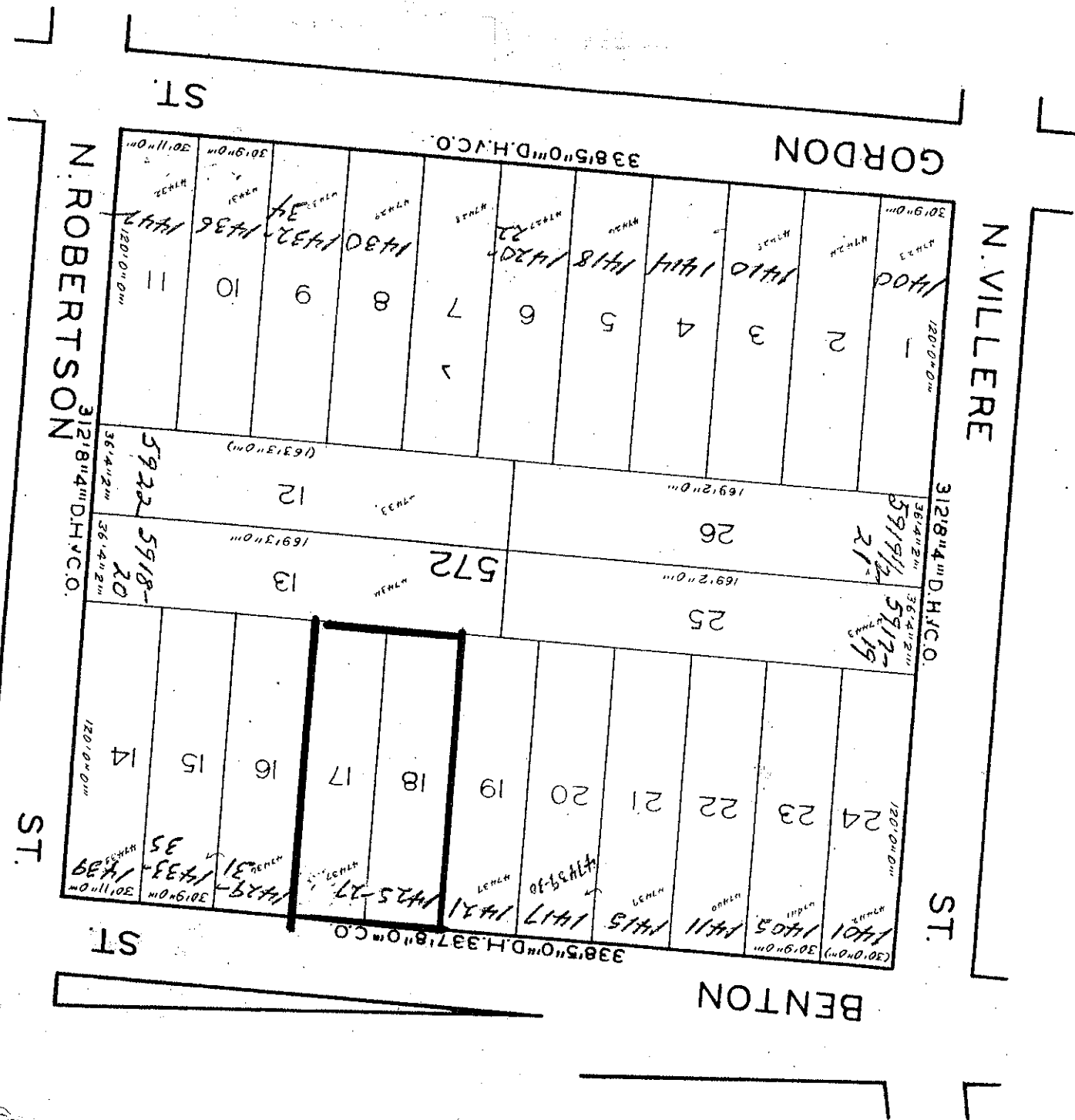
IT IS ORDERED, ADJUDGED & DECREED, that there be judgment herein recognizing & decreasing: EDWIN C. GONZALES and OLIVIA PORTIN (OR POART) to be the owners of prop. hereinafter described, and condemning & adjudging the des. prop. unto the HOUSING AUTHORITY OF NEW ORLEANS upon payment of the amt. hereinafter stipulated, which prop. is fully des. as follows:

A portion of ground, 2nd Dist. [36. 572] bb benton St., N. Robertson St., Gordon St., & N. Villere St. des. Nos. 17 & 18. as follows: Comm. at intersection of southerly right of way line of N. Robertson St. & easterly right of way line of Benton St. meas. S 32°13' W along easterly right of way line of Benton St., 92°4'-0" to point, the point of beginning; meas. S 66°47' E, 120'; thence S 23°13' W, 61'6"; thence N 23°13' E along easterly line of Benton St. 61'6" to point the point of beginning. ACC. 308 607, to 561

IT IS FURTHER ORDERED, ADJUDGED & DECREED that the above des. props. be condemned & adjudged to the HOUSING AUTHORITY OF N.O. in fee simple, absolute title, free & clear of all liens, encumbrances, servitudes, easements, charges, demands, claims, covenants, or restrictions of any nature whatsoever, for its uses & purposes, upon payment to the defendants adjudged owners herein, or upon deposit sub. to further orders of this Court, in the registry of this Court in the sum of \$3,300.00.

IT IS FURTHER ORDERED, ADJUDGED and DECREED, that out of the amt. when deposited in the registry of the Court, there shall be first paid, all State & city taxes and all unpaid assessments for paving & other local impts. against the aforesaid properties; & that all mortgages, liens, owners and claimants at interest be referred to the balance of the proceeds remaining on deposit, for payment of their obligations & settlement of their interests.
