WHEREAS, HANO is the owner of a fixed asset, one Ford E-450 Bus, VIN 1FDXE45F53HB58405 that has been determined to be surplus; and

WHEREAS, this vehicle is currently inoperable and its value is estimated at \$12,000; and

WHEREAS, pursuant to HANO's Disposition Policy, a vehicle in HANO's possession may be disposed of through donation, sale (auction), trade-in or scrap; and

WHEREAS, HANO may consider donating fixed assets to other entities when HANO fixed assets are required for public uses; and

WHEREAS, HANO has determined that said vehicle should be disposed of to a responsible entity capable of utilizing said vehicle in such a manner as to provide a benefit to the community; and

WHEREAS, Guste Homes RMC requested that HANO donate its fixed asset, one Ford E-450 Bus, VIN 1FDXE45F53HB58405 for the convenience and benefit of its residents; and

WHEREAS, Guste Homes RMC will provide a service to the community ensuring its residents have viable transportation;

THEREFORE BE IT RESOLVED, that the Board of Commissioners of the Housing Authority of New Orleans hereby authorizes the disposition of the fixed asset vehicle in HANO's possession, Ford E-450 Bus, VIN 1FDXE45F53HB58405 by donation to the Guste Homes Resident Management Corporation in accordance with HANO's Disposition Policy . The Board of Commissioners also authorizes HANO's Administrative Receiver to execute any and all documents necessary to effectuate the donation of the vehicle.

On October 18, 2011, HANO's Board of Commissioners approved the disposition of 35 vehicles from HANO's fleet based on those vehicles being inoperable, salvage, or surplus. One of the vehicles approved for disposition as a surplus vehicle is a 2003 Ford E-450 Bus, VIN 1FDXE45F53HB58405. HANO has since received a request from the Guste Homes Resident Management Corporation (GHRMC) to donate this vehicle to the GHRMC. The donation of this vehicle will allow the GHRMC to provide transportation for seniors and youth to various events for the benefit of residents of the Guste Homes and Fischer sites. The GHRMC manages both sites.

HANO staff has indicated that the vehicle has not been utilized by HANO for approximately two years. The vehicle is currently located at HANO's Central Maintenance Department. The vehicle has a remaining useful life of six years. In its current condition, the vehicle is valued at approximately \$12,000.

At this time, the HANO Finance Department is managing the HANO fleet. Accordingly, HANO's Finance Department requests approval to allow the donation of this vehicle to the Guste Homes Resident Management Corporation in accordance with HANO's Fixed Asset Policy for the disposition of surplus equipment.
