RESOLUTION NO. 2018-01

WHEREAS, the Housing Authority of New Orleans (HANO) annually obtains insurance coverage to protect its assets from loss and to comply with the United States Department of Housing and Urban Development (HUD) guidelines; and

WHEREAS, HANO's policies for these coverages are in effect for the period January 28, 2018 to January 28, 2019; and

WHEREAS, staff met with the Development, Asset Management & Operations Committee on January 23, 2018 and discussed the renewals and reviewed the preliminary premium quotes received by Marsh USA, Inc.; and

WHEREAS, the solicitation process was completed and final quotes were submitted to HANO on January 24, 2018, and based on the proposals submitted to HANO for review, HANO will maintain the same level of coverage for the next year and obtain the insurance for a slight increase; and

WHEREAS, HANO staff reviewed the highest ranking proposals and recommended the following policy package to the Executive Director:

Re: Annual Renewal of Property and Liability Insurance Policies

The Housing Authority of New Orleans (HANO) carries a variety of insurance policies related to our property portfolio and operations. Our policies are renewed on an annual basis.

Our insurance agent, Marsh USA, Inc., submitted estimated premiums which were discussed at the Development, Asset Management & Operations Committee meeting on January 23, 2018. The previously approved HANO budget line item (for fiscal year 2018) was reviewed as well as anticipated increases in the overall premiums for the next year. Staff met with Marsh USA on January 24, 2018 to review the final proposals. Staff met with the Executive Director and finalized its recommendations.

HANO carries all of the United States Department of Housing and Urban Development (HUD) required insurance and also provides coverage for Directors and Officers and HANO PD, which are highly recommended by HUD but not required.

As per the attached documents, the property premium increased 10% overall due to market rate increases related to catastrophic natural disasters in 2016 and 2017. The General Liability portion also saw an increase due to the addition of 204 additional housing units being added to HANO's portfolio.

All policies were required to be renewed no later than January 28, 2018 to avoid any lapse in coverage. At the Committee meeting of January 23, 2018, the Committee authorized the Executive Director to bind coverage prior to the January 28, 2018 expiration date. Accordingly HANO requests that the Board of Commissioners of the Housing Authority of New Orleans approve the insurance renewal coverage and ratify the actions of the Executive Director in binding

coverage and executing the documents necessary to avoid the lapse in coverage prior to expiration, and to remit the premium in the total amount of \$1,326,001.
