**Q1: IS THERE A CERTAIN PERCENTAGE OF DBE PARTICIPATION OR WBE
PARTICIPATION REQUIRED?**

A1: Pursuant to Part I of the Employment, Training, and Contracting Policy, "This policy applies to all contracts valued at \$100,000 or greater."

**Q2: On C-4 their product number given is incorrect. Also it says "legs" when
I'm pretty sure they mean the SSU "armcaps". Please clarify.**

A2: See Item #3 below.

The legs are to be SSU.

Q3: C-8 the product number is also incorrect.

A3: See Item #3 below

**Q4: In Items S-2 and S-2a of the specifications, there are (5) 30"W lateral
files and only (2) 60"W tops. Please confirm if this is correct.**

A4: This is correct. There are 2 sets of 2 (S-2) filing cabinets that receive S-2a. The fifth S-2 is under the built-in reception desk.

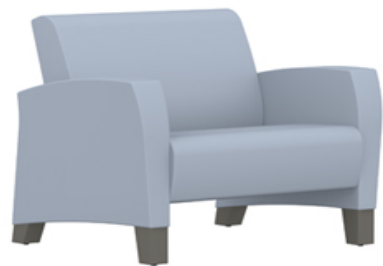
