Dear Housing Choice Voucher Applicant:

You applied to the Housing Authority of New Orleans' (HANO) Housing Choice Voucher Program (HCVP) waiting list. HANO currently has units available through another housing program, the Project-Based Voucher (PBV) Program, and is notifying you of the opportunity to apply for the PBV program.

The PBV program works similar to the HCVP and the subsidy is calculated using 30% of our annual gross income towards rent. However, the subsidy is in connection with the PBV unit and cannot be transferred to another unit. However, after residing in the PBV unit for 12 months, the participant may request to a Housing Choice Voucher under certain stipulations; for example, if there is a voucher available and you have fulfilled the terms of your lease. Please note that it is not guaranteed that the PBV participant will receive a Housing Choice Voucher after their first year of participation.

If you are interested in applying for the Project-Based Voucher program, beginning November 26, 2018, please follow the steps listed below:

- **Review below the list of available properties.** It is recommended that you visit the properties prior to applying.
- **Log on to HANO's application website** at <https://hano.apply4housing.com/>.
- **Select the property or properties you would like to apply for** by checking the box for each property.

**You must log-on to HANO's website at hano.org to apply to any/all PBV lists by May 24, 2019 at 4:00 p.m.**

**Applying for any PBV waiting lists will not affect your place on the HCVP waiting list.**
